<b>What?</b>	<p><b>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</b></p> <ul style="list-style-type: none"> <li>* Social security number and transaction history</li> <li>* Purchase history and mortgage rates and payments</li> <li>* Checking account information and wire transfer instructions</li> </ul> <p><b>When you are no longer our customer, we continue to share your information as described in this notice.</b></p>

<b>How?</b>	<b>All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information; the reasons Landmark Title, LLC chooses to share; and whether you can limit this sharing.</b>

<b>What we do</b>	
<b>How Landmark protect my personal information?</b>	<b>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We will continue to enhance our physical, electronic and procedural safeguards as new technologies become available.</b>
<b>How does Landmark collect my personal information?</b>	<b>We collect your personal information, for example, when you:</b> <ul style="list-style-type: none"> <li>* <b>Open an account or apply for insurance</b></li> <li>* <b>File an insurance claim or provide your mortgage information</b></li> <li>* <b>Show your government issued I.D.</b></li> </ul> <b>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</b>
<b>Why can't I limit all sharing?</b>	<b>Federal law gives you the right to limit only</b> <ul style="list-style-type: none"> <li>* <b>Sharing for affiliates' everyday business purposes- information about your creditworthiness</b></li> <li>* <b>Affiliates from using your information to market to you</b></li> <li>* <b>Sharing for nonaffiliates to market to you</b></li> </ul> <b>State laws and individual companies may give you additional rights to limit sharing.</b>

<b>Definitions</b>	
<b>Affiliates</b>	<b>Companies related by common ownership or control. They can be financial and nonfinancial companies.</b> <ul style="list-style-type: none"> <li>* <b>Our affiliates include TitleVentures, LLC, TitleQuest of Hampton Roads, LLC, TitleQuest Greenbrier, LLC, Real Estate Security Agency, LLC, and TitleCom, LLC.</b></li> </ul>
<b>Nonaffiliates</b>	<b>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</b> <ul style="list-style-type: none"> <li>* <b>Landmark doesn't share with nonaffiliates so they can market to you</b></li> </ul>
<b>Joint marketing</b>	<b>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</b> <ul style="list-style-type: none"> <li>* <b>Landmark doesn't jointly market.</b></li> </ul>
